Residential Living:

Visitation Requirements: We are happy to announce that effective Friday, March 26th we opened our campus to residential living family and friends. Guest will no longer be screened at our entry point to campus and will be allowed to freely visit their loved ones in their respective apartments. This will also include allowing overnight guests for the already established maximum timeframe of 2 weeks.

Unfortunately, due to our current Bistro renovations currently underway, guests will need to wait a little longer to “dine-in” with their friends. Once our Bistro opens May 3rd, guest will be able to eat in our dining room area with their friends.

Both guests and residents can visit common areas within our community, and have full access to our fitness room area, Library, Computer Lab, and Game Room. Unfortunately, due to our current limited seating capacity in our auditorium, only residents can attend Chapel Services at this time.

We will continue to operate within the guidelines of our local county restrictions related to COVID-19, by continuing and/or suspend visitation based on their guidance. Guests will be required to adhere to wearing a well-fitted mask when on campus grounds, and be vigilant in washing or sanitizing hands before, during, and after visits.

Assisted Living:

Effective April 5th we are expanding our visitor restrictions to now include in room general visiting. We will continue to have the option for those that choose to meet in the memory care garden or the off-unit visitor lounge. These visits will continue to be scheduled based on availability for 30 minutes each and by appointment only. Our in-room visits will be coordinated by our activities and nursing department. In-room visiting are scheduled on Mondays, Wednesdays, & Fridays between the hours of 9am to 4pm with the last appointment time being at 3:00pm. Residents are allowed up to 2 persons per indoor visit. Visitations can be scheduled by calling 954-475-5454

** All visitors regardless of vaccination status are screened for COVID symptoms prior to entering resident’s apartments

** All visitors regardless of vaccination status are required to wear a facial mask during entire visit.

Skilled Nursing Care:

Visitation Requirements:

How many visits

- Outdoors- every 30 minutes from 9:30- 4:30 pm 7 days a week.
- Indoors- every 30 minutes Monday-Saturday.
 - Designated visitation area in the care center
 - 2 appointments every 30 minutes.
 - Each patient can have up to 2 individuals inside

Location of visits

- Outdoors- Visitors lounge and patio at front entrance of care center
- Indoors- sitting area near the Palm Villa elevator

How to schedule- Call front desk of Care center 954-370-8982.

- All visitors will wear masks during inside and outside visitation regardless of vaccination status.

Amenity Areas:

- Dining – Assisted dining room and main dining room are open. One resident per table. (minimum capacity)
- Activities- group activities continue with minimum capacity. Live music will begin outside this month (April).
- Chapel Services- Thursdays at 11am
