Residential Living:

- **Visitation Requirements:** Up to five visitors permitted to visit in apartment. When entering the campus, notify our Welcome Booth greeters that you will be visiting a Residential Living Resident (screening not required). Please wear masks while in public areas on campus (Lodge, building lobbies/hallways) and maintain social distancing.

Amenity Areas:

- **Dining:** Guests are welcome to join residents for lunch and Sunday brunch by reservation, with masks and six feet social distancing. Dinner is open seating for residents who have been vaccinated.
- **Fitness:** the gym is open for vaccinated residents
- **Activities:** Resident activities on campus have resumed with committee meetings, gatherings in common areas and with expanded use of the Fellowship Hall up to 50% capacity (maximum 60) for vaccinated residents.
- **Chapel Services:** Chapel Services will resume Sunday for Residential Living Residents only on April 18 at 11:00 AM for up to 60 vaccinated residents in person and broadcast on CCTV.
