Residential Living:

Visitation Requirements: Visitation is open for Residential Independent Living. Residents and visitors who have not been fully vaccinated are asked to continue wearing a mask. Social distancing should still take place when in common areas of the Community. Guests to residential independent living areas are no longer required to be screened upon arriving to campus.

Amenity Areas:

- Dining – The Cherokee Dining Room, Perryman’s Bistro and the Glenlivet Lounge are open for business. Guests are welcome. Masks are recommended but not required for fully vaccinated people.
- Fitness – The Joe Holliman Fitness Center is open 24 hours a day to residents. Fitness classes have resumed.
- Pool – The pool is open and available for residents and employees, Mon-Fri from 7:00am-4:00pm.
- Activities – Activities are available and occurring both on and off campus. Please refer to the calendar for more information on specific events and programs. Fully vaccinated residents, employees and visitors are encouraged but not required to wear masks when social distancing is possible. Non-vaccinated persons are required to wear masks.

Redbud Court Assisted Living:

Visitation Requirements: Visitation is open in Redbud Court Assisted Living between the hours of 9:30am-8:00pm. The number of visitors per household is limited to four per visit at this time. Masks and social distancing must take place for the duration of the visit while indoors. If social distancing is taking place while outdoors, masks are not required. All visitors to Redbud Court Assisted Living must pass the COVID screening process at the gatehouse when entering the Community.

Amenity Areas:

- Dining – The dining room is open for all meals. Limited seating capacity remains in place and guests are welcome as space and capacity permits.
- Activities – Activities are taking place on and off campus. Please refer to the calendar for information on specific events and programs.

Heather Hall Skilled Nursing:

Visitation Requirements: Visitation is open in Heather Hall Skilled Nursing between the hours of 9:30am-8:00pm, seven days a week. Visitation must be pre-arranged by calling Sharon Goforth, (918) 388-4279 during regular business hours Monday-Friday. The number of visitors per resident is limited to two per visit at this time. Masks and social distancing must take place for the duration of the visit while indoors. If social distancing is taking place while outdoors, masks are not required. All visitors to Heather Hall must pass the COVID screening process at the gatehouse upon arrival to the Community.

Amenity Areas:

- Dining – the Dining room is open to residents for all meals.
